Dear Senator Gillibrand,

We, the Executive Committee of Westchester Jewish Coalition for Immigration, are writing to ask you to urge the Biden administration to swiftly sign the Presidential Determination on Refugee Admissions for Fiscal Year 2021.

As a Jewish organization that advocates for immigrant rights, we firmly believe that every person seeking refuge in the United States is entitled to due process and dignity. The Biden administration has made bold commitments to revitalize the U.S. refugee resettlement program. Now the administration must begin to fulfill them. President Biden must act on the promise he made to sign a new framework for refugee resettlement. In doing so, people who have fled persecution to seek a new life in a safe place will once again have a chance to find it in the United States.

As we face the worst refugee crisis in history, each day that passes without a change to the Presidential Determination is another day hundreds of particularly vulnerable refugees are forced to wait for safety and protection. The administration has already met with Congress to discuss its proposed changes to the Presidential Determination, and the president must now make it official.
